My profound gratitude to you all and to our Patron, Ambassador Kariyawasam, Vice Patrons Dr, Barr and Mr. Dahanaike, Past Presidents and the Advisory Board members for their guidance and support.

### MINUTES OF THE 41<sup>st</sup> ANNUAL GENERAL MEETING OF THE SRI LANKA ASSOCIATION OF WASHINGTON, D.C., (SLAWDC) AND THE SRI LANKA ASSOCIATION OF GREATER WASHINGTON, INC. (SLAGW) HELD ON SUNDAY, MARCH 20, 2016

The 41<sup>st</sup> Annual General Meeting of the Sri Lanka Association of Washington D.C. (SLAWDC) and its tax Exempt affiliate, Sri Lanka Association of Greater Washington, Inc. (SLAWGW) was held on Sunday, March 20th, 2016 at the River Road Unitarian Church, 6301 River Road, Bethesda, Maryland with President Kamini Wikramaratna as the Chair. Associated with the President in conducting the meeting was Secretary, Gayani Vithanage.

With a quorum of 33 out of the 83 Members, the 41<sup>st</sup> Annual General Meeting called to order at 3:40pm.

Mrs. Wikramaratna welcomed everyone to the 41<sup>st</sup> Annual General Meeting of the Sri Lanka Association Of Washington D.C. (SLAWDC) and the Sri Lanka Association of Greater Washington, Inc. (SLAGW).

Adoption of the Agenda and the Notice convening the 41<sup>st</sup> Annual General Meeting of the Association The Agenda and the Notice convening the 41<sup>st</sup> Annual General Meeting was adopted as in order: Proposed by Mr. Lasantha Dhanaike and seconded by Mrs. Anjalika Silva.

Adoption of the Minutes of the 40<sup>th</sup> Annual General Meeting of the Association held on March 22, 2015 The Minutes were proposed by Mr. Suraj Navaratna and seconded by Mr. Indika Attanayaka.

## Adoption of the Annual Report and the Statement of Accounts of the Association for the year Ending January 31, 2016

The Statement of Accounts were proposed by Mrs. Gothami Gunasekara and seconded by Mr. Bernard Wickramanayake.

#### **President Speech**

Mrs. Kamini Wikramaratna welcomed everyone who came to the AGM and stated that last year was a successful year and she couldn't have achieved what she did without the support of the members and the Board of Directors. Mrs. Wikramaratna also stated that last year's Avurudu was a successful event. She stated that the highlight of the year was the "meet and greet" she had with the Past Presidents Of SLAWDC and the Ambassador. One thing she observed at the event was the friendships and unity for each other and she was very proud to be a part of that legacy. Mrs. Wikramaratna said, last year was a very successfull year celebrating the 40<sup>th</sup> Anniversary of SLAWDC. She also mentioned the 40<sup>th</sup> Anniversary Dance, was a successful event as this had been the first time a SLAWDC event was sold out within one week of the event. She mentioned she was able to double the finances. Mrs. Wikramaratna said it was very enjoyable year until the very last two months, where there had been disagreements with her Board that couldn't be resolved. Mrs. Wikramaratna stated that it is for the best of SLAWDC that she and Board resign and a new Board takes over. She thanked Lasantha Dahanaike for mediating between her and the Board of Directors, and for coming to an agreement to resign immediately. Mrs. Wikramaratna called upon the Election Commission to conduct the election of the Board of Directors for 2016 for SLAWDC and for SLAGW.

#### **Vote of Thanks**

Dr. Raj Barr started his speech stating that 40<sup>th</sup> year is an important year, and that in life it's called the "midlife crisis," which SLAWDC happened to go through. He also said in a positive note that he has seen the Board of Directors act exceptionally well together. He stated it was a pleasure getting to know the Board and also stated that each member fulfilled his or her slot. He said it's time to reset, as the family has come to disagreements. He stated he thought the Association was dead and he was impressed that the Board pulled Through with the 40<sup>th</sup> Anniversary celebration, which was a sold out event for the first time. He said achievements of the past board should be celebrated and thought it would be futile to reconstitute the Board, but left it up to the membership. Dr. Barr concluded his speech stating that this is just a vote of thanks.

#### **Election Proceedings for Board of Directors-**

Chair Elections committee Mr. Dakshi De Silva and committee member Mr. Roy Braine took over the proceedings of the elections. Mr. De Silva Explained to the membership that a President-elect will be first elected who will immediately take the position of the President and that a second President-elect will be elected as the President-elect.

He stated that the agreement was for the Board to resign and none of the issues be brought up at the AGM in order to prevent any unnecessary disagreements.

Mr. De Silva as Chair elections committee announced that Mrs. Wickramaratne was ineligible to stand for reelection as per Article 7 (viii) of the constitution that states "an outgoing President shall not be eligible to be a candidate for a position on the board for one year after he ceases to be President."

Chair Elections committee then asked that all candidates step outside to start on the voting.

Chair elections committee suggested that the voting be to vote out the candidate that is to be eliminated. Chair offered to give a brief biography for each of the candidates when their names were announced.

Mr. Abeywarna— served on the Board for a while. Worked on the IT and communications components along with being the webmaster. Also assisted with sports. He is a very able and willing Director.

Mr. Herath – current IT and webmaster for the association. New website was created by Ramesh

Mr. Abeysinghe- served for 4 years. Active member in the community and the committee

Mr. Pushpakumara – Has served in the Board for 6 years. And is very active during events

Mr. Kularatna – Official photographer and is in-charge of creative work

Mr. Buddhadasa – life member

The question was asked why we couldn't have 6 Directors and it was explained that the constitution will need to be changed in order to accommodate that and also there will not be a majority if there is a vote from a 12-member Board vs. 11-member Board.

Harsha Buddhadasa, walked back in to the room to explain that he will not have the time to devote to the work of the Board and that he is withdrawing his name.

Chair concluded the voting and thanked the Members for being present and for their support. He welcomed and congratulated the President who he said he has worked with in the past. He also congratulated the new Board and asked the new President to preside the meeting. He stated he was happy that a full slate was elected after a few years and invited the new president and the Board to take control of the rest of the proceedings. The incoming President invited the new Board to take their seats.

#### President's speech

President Rashika Weerasena opened her comments mentioning that she had not come with a prepared speech as the election to the Board was unexpected; she continued to address the membership:

Past Presidents, outgoing committee, current members, Family and friends,

Thank you for being here and I am honored and humbled to be elected as president SLAWDC, the oldest Sri Lankan organization in the Washington DC area. As we saw today, we do have conflicts and issues and I am hoping we can work through all of these together and make the organization much stronger going forward. I hope all of you - immediate past President, all past Presidents, the past Board and the membership - will support me with these efforts. Let's try and build the association together. Perhaps, going back to some of the same events as a start and with your feedback on how/what we need to do, we can look at other areas. Thanks again for being here and I welcome the new Board and I hope to work together in the coming year.

#### **Appointment of the Honorary Auditor**

Since the Honorary Auditor Mr. Suraj Navaratne was appointed last year for a two-year term, he was nominated to continue for the second year.

#### **Any other Business**

Strategic planning exercise.: Ms. Anjalika Silva reminded the Board and the members that the 2-year strategic plan needs to be implemented with about 4-5 trusts. A standard operating procedure manual needs to be created to keep the office bearers informed of their duties. Ms. Silva volunteered to assist with this project.

Regulatory Requirements: Dr. Raj Barr mentioned that the state of MD and Federal laws need to be addressed. He mentioned that we have been operating the non-profit foundation without the proper guidelines being followed. Ex: Not having a SLAWGW treasurer in the past year. Dr. Barr urged that we look in to these urgently and offered to assists us if needed.

Mr. Dakshi De Silva thanked Mr. Lasantha Dahanaike for mediating with the Board at a critical time. He urged that the Board work together and to think outside the Box and rethink the needs of the community. Ms. Shenaz Dave took the opportunity to thank Mr. Dakshi De Silva for his support in the past year.


#### Sinhala and Tamil New Year Celebrations

The Board of Directors are pleased to present the following Annual Report of the Sri Lanka Association of Greater Washington, Inc. (SLAGW).

#### Governance

The Board of Directors of the Sri Lanka Association of Washington, D.C. (SLAWDC), duly elected at the 41<sup>st</sup> Annual General Meeting (AGM) held on March 21, 2016, provides the overall guidance, stewardship and management to SLAGW. As the affiliate organization of SLAWDC, responsible for its humanitarian, charitable and educational activities, SLAGW receives support from the parent organization in carrying out the mandate granted by its members. The Board held five meetings during the course of the year.

#### **Election of Honorary Auditor for 2016/2017**

Since the Honorary Auditor Mr. Suraj Navaratne was appointed last year for a two-year term, he was nominated to continue for the second year.

#### **Board Meetings**

The Board had five regular meetings and two working meetings during the year. Ms. Shenaz Dev sent in her resignation as at the AGM to be held on 2017 and conveyed that she will not be continuing her second year on the Board. Mr. Viraj Kularatne informed the Board that he will not be available to serve on the Board in 2017 once his term is up for reelection.

#### WWW.SLAWDC.org

The SLAWDC website continued to keep the community informed of SLAWDC/SLAGW activities as well as other events by keeping the community calendar updated. The community was also encouraged to advertise their businesses under "Community Businesses" for a nominal fee of \$150 per year. We received one banner from Baily Tea that is currently advertised on the site.

#### Serendib

The redesigned newsletter continued to include community news in addition to that of SLAWDC/SLAGW. The community was encouraged to send in articles to be included in the news-letter as well as advertisements. We received one half a page advertisement from Banana Leaf for the December edition.

#### **Finances**

SLAGW total funds collected for the period ending January 31, 2016 is \$770. The total distribution of funds for the period from February 1, 2016 thru January 31, 2017 was \$500. The Balance as of January 31, 2016 is \$1666.09

#### **SLAGW APPROVED CHARITABLE ACTIVITIES**

#### Ceylon School of The Deaf & Blind, Ratmalana (Donated \$500.00 in 2016)

Founded in 1912, Ceylon School of The Deaf & Blind is a residential institution, catering to impaired children in 3 schools, irrespective of race or religion. The school provides free board and education to the children most of whom come from very poor backgrounds and the largest expense is food as the children are served 3 main meals and evening tea each day, where the emphasis is on wholesome nutritious food. After an absence of a few years, the SLAGW Board made contact with the school and donated \$500.00

#### **HelpAge (No Donation/Pledges in 2016)**

Helpage is an organization whose mission is to improve the quality of life of all senior citizens in Sri Lanka, irrespective of religion, caste or race. They have two decades of experience working with vulnerable senior citizens and providing health and eye care, training of volunteers for voluntary home care, youth education on understanding the needs of Elders. These housing projects are built with the objective of becoming self-sustaining communities. The Elders who attend Day Centers follow a program designed according to their specific needs which includes suitable daily exercise routine, recreation, income generation activities, religious activities, provision of medical services and advice etc., HelpAge also assists these organizations to register with the National Secretariat for Elders' as Senior Citizens Committees. http://www.helpagesl.org/. http://www.helpagesl.org/

#### **NEST, Hendala (No Donation/Pledges in 2016)**

NEST is an organization that offers rehabilitation and support services to people diagnosed with long-term illnesses such as AIDS, victims of drug abuse, mental illness, etc. Two main goals of NEST are: 1) to steer people away from prolonged institutionalization by bringing them in to the halfway home surrounded with peace, calm and tranquility and medications when deemed necessary. They are then taught life-skills, and reunited with family and the community; 2) to take a firm stand on denouncing stigmatization, as it plays a major role in the recovery process, and enhancing the quality of life.

#### Manrosa Home Of Love, Dankotuwa (No donations/Pledges in 2016)

Manrosa home of love is a home that accommodates female elders selected from among the poorest of the poor in society, who have been left destitute for various reasons. The home does not receive government or international funding and the local community brings in donations of dry rations and alms. The home does not discriminate against race, community or religion.

#### Richmond Fellowship (No Donations/pledges in 2016)

Richmond Fellowship is a registered NGO under the Voluntary Social Services Act in Sri Lanka that offers skilled care to those who are mentally and emotionally disturbed and who require rehabilitation and then re-integrate with family and the community. RFL provides accommodation for a total of thirty males and females for an ideal period of 6 to 12 months with some exceptions and is linked to similar organizations offering a global network of therapeutic communities. http://www.richmondfellowshiplanka.org/about.html
